QUICK-REFERENCE RULES

Rule	Point or Motion	Second	Debate	Description	
6.1	*Point of Order	No	No	Used to point out an error in procedure. Requires a ruling of the Chair.	
6.2	*Point of Privilege	No	No	Used to raise a concern to the Chair. Requires a response from the Chair.	
6.3	*Point of Inquiry	No	No	Used to ask a procedural question of the Chair.	
7.1	Adjourn	Yes	No	Motion used only at the end of a committee or plenary session to conclude the meeting. Simple majority.	
7.2	Recess	Yes	No	Motion for suspending the meeting for a specified time period. Simple majority.	
7.3	Consider a Topic Area	Yes	Yes	Motion that brings a topic to the floor for debate. Simple majority.	
7.5	Close Debate	Yes	Yes	Ends debate on a topic. Any draft resolutions and amendments on the floor are voted on. Simple majority.	
7.6	Bring an Item to the Floor	No	No***	Used to bring an approved draft resolution or amendment to the floor. Automatically accepted; no vote.	
7.7	Limit	Yes	Yes	Can be used to establish a limit on speaking time or limit the length of debate on a topic. Simple majority.	
7.8	**Division of the Question	Yes	Yes	Used during voting procedure to highlight a specific portion of a draft resolution. Must be submitted in writing before voting procedure.	
7.9	**Adopt by Consensus	No	No	Used during voting procedure to adopt a draft resolution without a recorded vote. Requires no objection.	
7.11	Table	Yes	Yes	Temporarily removes a topic or draft resolution to be considered later. Roll call vote; simple majority.	
7.12	Reconsider	Yes	Yes	Brings a tabled item back to the floor. Motion must be made by a delegation that voted in favor of tabling. Two-thirds majority.	
8.3	**Roll Call Vote	No	No	Used to request a recorded vote on a draft resolution.	

^{*} This point may be used during voting procedure.

^{**} This motion may only be used during voting procedure.

^{***} When a committee resolution is brought to the floor in a plenary session, the chair may recognize speakers in favor of the resolution and allow for extended speaking time.


I look forward to an exciting and productive conference and cannot wait to see the impact you will make. Welcome to MMUN 2025!



KEYNOTE SPEAKER



Reid Detchon is Senior Advisor for Climate Solutions at the United Nations Foundation. He previously served as the Foundation's Vice President for Energy and Climate Strategy from 2006 to 2017. He also served as Executive Director of the Energy Future Coalition, a non-partisan domestic policy initiative.

The Foundation's engagement with the UN on energy and climate issues has included communications support for the IPCC's Fifth Assessment Report, as well as creation of the Earth To Paris coalition to build a drumbeat of action and awareness for COP 21. Other activities include support of the Secretary-General's initiative on Sustainable Energy for All – whose objectives are now reflected in Goal 7 of the new post-2015 Sustainable Development Goals – as a model of public-private engagement with the UN.

Mr. Detchon previously served as Director of Special Projects in Washington for the Turner Foundation; as a principal at Podesta Associates (now the Podesta Group), a government relations and public affairs firm in Washington; as the Principal Deputy Assistant Secretary for Conservation and Renewable Energy at the U.S. Department of Energy from 1989 to 1993; as principal speechwriter for Vice President George H. W. Bush; and as a staff member and legislative director for U.S. Senator John Danforth of Missouri.
